Official Contest Rules ("Rules")

Oven Baked Tradition™ (the "Brand")

1- CONTEST PERIOD

The Oven-Baked Tradition™ "Fly away with a \$3,000 travel credit" Contest organized by Bio Biscuit Inc (the **"Organizer"**) begins on October 6, 2025 at 9:00 a.m. (EDT) and ends on November 30, 2025 at 11:59 p.m. (EST). All references to these Rules relating to time refer to Eastern Time (ET) (the **"Contest Period"**).

2- ADMISSIBILITY

In order to be eligible to participate in the Contest, a participant must (i) be an individual, (ii) be a legal resident of their province, and (iii) have reached the age of majority in their province of residence at the time of entry into the Contest (" **Participant**").

Employees of the Organizer, its agents and/or representatives or affiliated companies and stakeholders related to the Contest, as well as, respectively, any member of the immediate family of such employee, agent and/or representative are not eligible to participate in the Contest. For the purposes of these Entry Rules, "Immediate Family" means the father, mother, brothers, sisters, children, husband and wife or common-law partner, brother-in-law, son-in-law, daughter-in-law or sister-in-law of such employee, agent and/or representative, whether or not they reside at the same address.

3- HOW TO ENTER THE CONTEST

3.1 No purchase necessary. To obtain one (1) entry, write your name, address, including city, province or territory, postal code, telephone number, email address and write a three hundred word (300) word text (the "Text") describing your favorite activity with your pet and mail it to the following address: "Oven-Baked Tradition ™ " Fly away with a \$3,000 travel credit " Contest Bio Biscuit Inc., 5505 Trudeau Avenue, Saint-Hyacinthe, QC. J2S 1H5. The mailing must be postmarked no later than November 21, 2025 and the shipment must be received no later than November 28, 2025. Each entry must be accompanied by a different Text. Only one entry is allowed per eligible envelope. Duplicate, incomplete or inaccurate entries will be void.

Documents produced using a script, macro, robot, other programs or mechanically reproduced will not be accepted, as will multiple or batch entries. Maximum of eight (8) entries using this method.

- 3.2 With purchase. To enter with purchase, the Participant can register through the Contests tab at the following address: https://www.ovenbakedtradition.com/en/giveaway/ (the " Contest Site"), complete an online entry form and validate it as indicated (the "Entry Form"). To complete the Entry Form, the Participant must indicate their last name, first name, complete email address and telephone number. All data entry fields on the Entry Form must be completed unless indicated as optional. Any Entry Form for which the mandatory information provided is incomplete or inaccurate may be declared ineligible to participate in the Contest. The Organizer reserves the right, in its sole discretion and at any time, to request proof of identity or eligibility to participate in the Contest. A Contest Participant may only use one (1) email address to enter the Contest Site. Only one (1) Entry Form per Participant per day per email address for each proof of purchase for the entire Contest Period. The Organizer reserves the right, in its sole discretion, to disqualify any individual found to be in violation or attempting to violate the Contest Rules. Automatic entries are strictly prohibited, and any direct or indirect use of automatic devices will result in the immediate disqualification of the participant and their accomplices, with the Organizer reserving all its rights and remedies against the user of these automated devices and their accomplices. For this method of entry with proof of purchase, a Participant must have made a purchase of a Bio Biscuit Inc. product bearing the Oven-Baked Tradition Brand's logo in one of the participating stores during the Contest Period and complete the Entry Form as provided in this article 3.2 and produce proof of purchase of the product, i.e. a sales receipt (PDF or JPEG format) and upload this proof of purchase on the Contest Site to validate his entry.

5- DRAW

Draw Time: 11:00 AM Eastern Standard Time (EST)

The draw shall take place at the Organizer's office, at 5505 Trudeau Avenue, Saint-Hyacinthe by a minimum of two (2) representatives of the Organizer.

Draw Details: Random selection of one (1) Participant per region from all valid Entry Forms registered during the Contest Period

The odds of winning a prize depend on the total number of eligible Entries received during the Contest Period

Prizes are subject to the terms and conditions of use of the prize provider. Additional restrictions may apply. No warranty other than that of the manufacturer or the supplier of the prize will be applicable. The Organizer has no liability for the prize once awarded.

6- PRIZE CLAIM

Winners will be contacted by phone or email within seven (7) business days of the draw, using the contact information provided at the time of entry. If you have not provided a phone number or email address, you are not eligible to receive the prize.

In order to be declared a winner, any selected Participant must:

- a) be reachable by telephone or email, at the sole discretion of the Contest Organizer. Any selected Participant who cannot be reached within seven (7) business days of the first attempt by the Organizer will be disqualified, and a new draw will be held to award the prize to another Participant.
